## Introduction

The training action for partners MPCs LAs (Jordan and Lebanon) is aimed at drawing up an action plan, as well as at starting a participatory process, to make local development more sustainable and shared, more equitable and environmental friendly with particular reference to the waste management and the use of renewable energy sources.
